The Social Enterprise Legal Models Working Group was formed in 2011 and is comprised of social enterprise developers, educators and legal practitioners. It has been examining the often overlooked question of what legal forms are available that might enable a social enterprise to preserve its commitment to social outcomes and to demonstrate that commitment to customers, financiers and the community. Drawing on a mixture of survey and research work, the Working Group has addressed a number of questions: Why is choice of legal form important for social enterprise? What are the key issues in choosing a legal form for a social enterprise business? What legal form options are available under current Australian law? What lessons can be drawn from developments in other countries?
